**Guidelines:**

1. Cost of space for the 2 days is \$65. **Please make checks payable to Bayshore CAPA Center, Inc.** No refunds will be given due to inclement weather.
2. **Application deadline for entry is November 30, 2011.** There are a limited number of booths available in each category. These are filled on a first come first served basis.
3. The Collier County CRA is not responsible for attendance, sales, or closure due to regulatory or licensing agencies.
4. Each artist must have a **white canopied tent** with sides for display. Please be sure to bring enough weights /tie downs to secure your tent in case of winds. This is a two day show so you must have sides for your tent to close it up in the evening. Table displays in your tent need to be skirted to the floor.

5. Each booth space is approximately 11 feet wide. There will be room in the back of the tent for storage.
6. Please make sure to bring a **DOLLY** to the show. You will be able to bring your car to your assigned spot to unload. **BUT YOU MUST UNLOAD COMPLETELY AND MOVE YOUR CAR BEFORE SETTING UP.** This directive must be followed so as to allow other artists to bring their cars into the show area. **You will not be able to leave your car behind your tent.**
7. There will be uniformed security on the grounds on both Friday and Saturday nights.
8. **This is a family event and, while artistic expression is welcome, we do reserve the right to censor artwork that may be inappropriate for this event.**
9. Each exhibitor must comply with all pertinent State of Florida sales tax regulations. Each artist is responsible for collecting and paying to Florida Department of Revenue, Florida Sales Tax of 6%.
10. No refunds will be made for cancellation by exhibitor.
11. Artwork must be original and created by the artist. No buy/sell products, kits, or cast mold productions allowed. We will not accept knitting, crocheting, dried floral arrangements or shell crafts.
12. Check in and setup will begin at **noon on Friday**. All vendors must be completely set up by 10:00 am on Saturday morning.
13. No vendor is to break down until the end of the event or otherwise communicated by event officials. NO EXCEPTIONS
14. **PLEASE NOTE: This year the festival has hours extended to 6:00pm on Saturday and Sunday and opens at 11:00 am each day.**
