Students may send up to 4 Jpegs of any 2D original work that they would like to be considered for this exhibit as well as a completed application and signed Artist Release Form via email to KDonovan@UACCollier.org. The title of each Jpeg attachment must include your NAME and the TITLE of the piece. In the body of the email, include title, medium, and framed dimensions for each attachment.

Work must be ready for installation: framed and/or gallery wrapped with D-Rings installed; no sawtooth hangers will be accepted.

Images submitted may be accepted or rejected by UAC staff as part of the curating process.

ARTIST RELEASE FORM

The Artist does hereby release, discharge and hold harmless the United Arts Council of Collier County; their officers, employees, volunteers and agents, of and from any and all claims, demands, actions, causes of action and suits at law or in equity for and on account of any injuries, damage, loss or accidents sustained by the Artist or Artist’s property while participating in the exhibits.

In the case of a natural disaster (hurricane, wildfire, etc), The UAC will secure the UAC gallery to the best of its ability. Artwork will not receive additional care. UAC will provide reasonable notice to artists if the office is going to close, at which point the artist may cover or remove artwork at their discretion.

The Artist retains all rights to the images and gives the UAC permission to reproduce images of the Artist’s work for internal and external program promotion as well as to post on Internet sites for publicity purposes. Images used for publicity will be properly credited to the artist with the image title.
